**FINAL JUDGMENT AGAINST MARK PERLMAN IN FAVOR OF PLAINTIFF, ABEL  
& ZIMMERMANN AND PLAINTIFF'S COUNSEL, SCOTT A. FERRIS**

IT IS ADJUDGED that Plaintiff/Judgment Creditor, Abel & Zimmermann and/or Judgment Creditor, Scott A. Ferris, shall recover from Judgment Debtor, Mark B. Perlman (SS#058-38-4833), not to exceed the following: Twenty-five Hundred Dollars (\$2,500.00) and 00/100 Cents as half of the sanctions awarded by the Court for Defendant's attorney, Mark B. Perlman contemptuous conduct in the above referenced matter; Forty-three Thousand Three Hundred Eighty-seven Dollars (\$43,387.50) and 50/100 Cents, as half of the award of attorney's fees in favor of Plaintiff/Judgment Creditor, Abel & Zimmermann and/or Judgment Creditor, Scott A. Ferris, pursuant to § 57.105, Fla.Stat.; and, Nine Thousand Four Hundred Fifty-seven Dollars (\$9,457.50) and 50/100 Cents, as

half the amount awarded to Plaintiff/Judgment Creditor, Abel & Zimmermann and/or Judgment Creditor, Scott A. Ferris for the attorney's fees, pursuant to § 57.105, Fla.Stat., for the unnecessary travel time incurred in this cause for the sum of **Fifty-five Thousand Three Hundred Forty-five Dollars (\$55,345.00) and 00/100 Cents**, for which let execution issue instanter and forthwith.

Plaintiff/Judgment Creditor, Abel & Zimmermann and/or Judgment Creditor, Scott A. Ferris shall further be awarded interest from Judgment Debtor, Mark B. Perlman, at the prevailing rate of 8% percent per annum from September 19, 1996 on the total amount of the judgment, Fifty-five Thousand Three Hundred Forty-five Dollars (\$55,345.00) and 00/100 Cents.
